## ADDITIONAL TERMS OF APPLICATION

---

### 1. TERMS INCORPORATED.

The Student assents to the following terms as a precondition to enrollment in any educational program offered by Yoga Three. These Additional Terms and the Application for enrollment shall collectively be referred to herein as the Application.

### 2. INHERENT RISKS.

The student acknowledges that while there are enormous health benefits to the study and practice of Yoga, there may at times be some attendant risks and hazards. The student assumes the risk and responsibility of all injuries that the student sustains or causes while in a Yoga Three facility or arising from Yoga Three instruction.

The Student accepts and assumes the risk of harm, loss, injury or damage as a result of the Student's participation in Yoga Three instruction or from the Student's presence at a Yoga Three facility. In no event shall Yoga Three or instructors be liable to the Student for consequential damages. The Student's sole remedy shall be in any case limited to the return of the Student's tuition where warranted.

The Student will indemnify and hold harmless Yoga Three, its instructors, members, officers, directors, employees, clients, customers and agents from any and all claims, losses, liabilities, damages, expenses and costs (including attorneys' fees and court costs) which result from a breach of Yoga Three policies or regulations.

### 3. ARBITRATION.

Any dispute arising out of or relating to the relationship between Yoga Three or its instructors and the Student which has not been resolved within 90 days after one party gives written notice that a dispute exists, shall be settled by an arbitrator located in Boston, Massachusetts in accordance with the rules of the American Arbitration Association pursuant to Expedited Procedure. The arbitrator shall first attempt to mediate the dispute, but to the extent that the dispute is not resolved by mediation, the arbitrator shall have the authority to conclude the mediation and to decide any remaining issues with or without any additional formal presentation of evidence as the arbitrator shall deem appropriate.

### 4. MISCELLANEOUS.

The Application shall be governed by and construed in accordance with the laws of the Commonwealth of Massachusetts. No modification or waiver of any provisions set forth in the Application shall be effective unless they shall be in writing and signed by the party against whom enforcement is being sought. No waiver by any party of any breach of shall be a waiver of any preceding or succeeding breach.

This instrument is intended by the parties to be the final expression of their agreement, and it constitutes the full and entire understanding between the parties with respect to the subject of it, notwithstanding any representations, statements, or agreements to the contrary previously made.
